



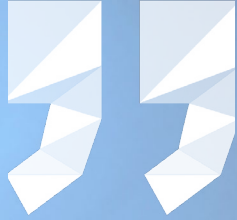

- Combine intercultural management skills and occupation-specific English abilities in order to work effectively in an international environment.

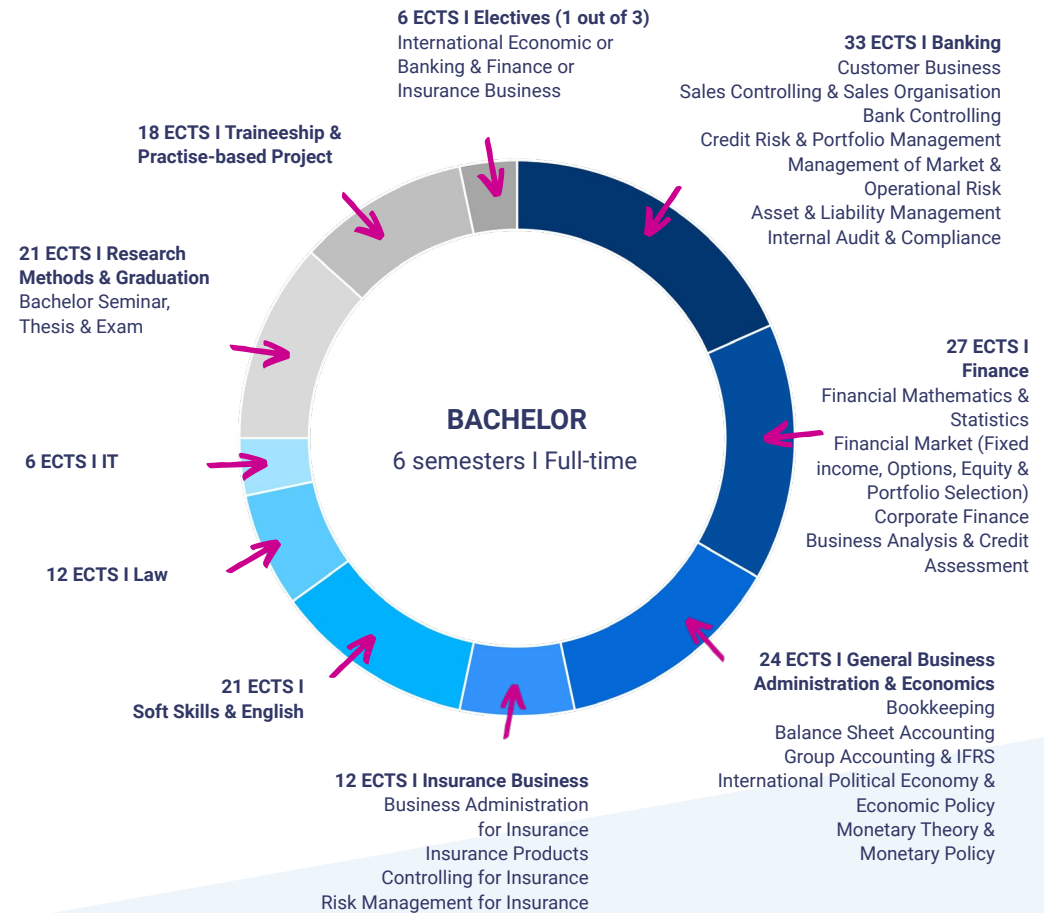

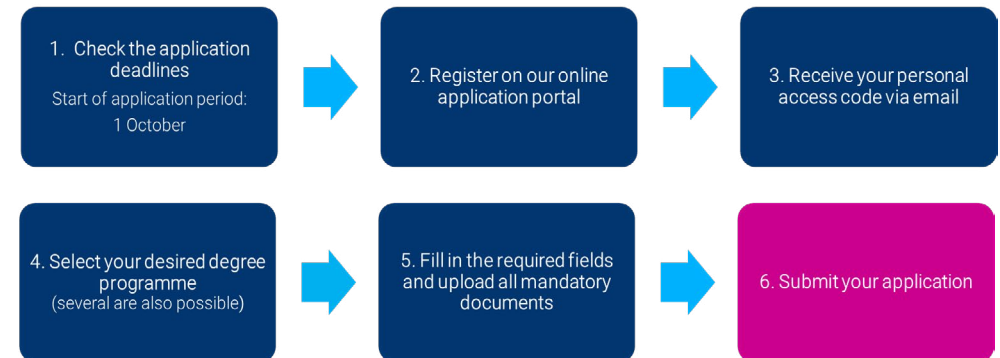
# Studying at UAS BFI Vienna

## Admission requirements

If you meet one of these admission requirements for the bachelor programme, nothing more stands in the way of your application:

- Austrian school-leaving certificate („Matura“) **or**
- Vocational matriculation qualification (“Berufsreifeprüfung“) **or**
- University entrance qualification exam (“Studienberechtigungsprüfung“) for social and business studies **or**
- A foreign certificate that is equivalent to one of these Austrian certificates **or**
- Completion of a relevant apprenticeship or a relevant school for intermediate vocational education plus supplementary exams in English and mathematics.

## Admission test for your desired degree programme

The admission test for bachelor programmes consists of the following test sections: reading comprehension, English, maths, business administration and a degree programme-specific part. The test takes place online between March and June. As soon as we have checked your application and you meet the admission requirements, we will invite you to the admission test via email. From the date of the email onwards, you will have seven days to book your test date yourself via the application portal. From the end of January/ beginning of February, preparation materials for the admission test will be available on our [website](#), which you can use to prepare yourself optimally.
